

WEBSITE PRIVACY POLICY

US Senior Pickleball (also known as “USSP”, “SSIPPA” or the “Super Senior International Pickleball Association”) legally owns and operates <https://usseniorpickleball.com> and associated domains/sub domains. The website serves to manage the organization’s mission and address commercial, educational, governmental, charitable, cultural, athletic and/or social functions and platforms. This Website Privacy Policy is created as a reference and directs associates with USSP on rights to privacy of members, clients, subscribers, and users.

This policy describes how we process any personal data we collect or that members and contacts provide to us through our website(s). We confirm that we will keep your information secure and that we will comply fully with all applicable Data Protection legislation and regulations. Please read the following carefully to understand what happens to personal data that you choose to provide to us, or that we collect from you when you visit this site. In compliance with the General Data Protection Regulation ("GDPR"), we will assign the current USSP President or delegate as Data Protection Officer ("DPO").

Information We Collect

We may collect, store and use the following kinds of personal information about individuals who visit and use our website:

- Basic personal details such as name, residence address, email address, telephone number, age, and gender.
- Business details such as business name, business address, business email address, business telephone number, and year established.
- Internet Protocol (IP) address, location, internet service provider (ISP), and cookies or HTTP cookies and other similar technologies to distinguish you from others on our website,
- Membership dues, product/service invoices and payment history,
- Your login and logout time, and
- The type of data or content you view on our website.

How We Use and Store Data

• DATA USE

Any and all kinds of personal and/or confidential information submitted or collected through <https://usseniorpickleball.com> and associated domains shall be apportioned, disclosed, and/or used only for the purposes of

- Providing you with information and/or services that you request from us,
- Improvement of products and/or services provided.
- Customization of the website for efficient and effective usage.
- Security and debugging as part of our efforts to keep our site safe and secure,
- Storage and records of the management.
- Contact information for marketing and promotional purposes; and

- Method of contact and/or communication between the management, its members, clients, subscribers, users, and relevant third parties associated with such website users.

• DATA RETENTION

We will only retain personal information and/or data within the necessary period to achieve the purpose set out in this Policy and will ensure that such retention is allowed by law. Any information you provide to us will either be emailed directly to us or may be stored in a database on a secure server. We use a trusted third-party website and hosting provider to facilitate the running and management of this website. The third-party provider cannot access, provide, rectify, or delete any data that they store on our behalf without permission.

• DATA TRANSFER

Your personal data may be transferred to and stored at a location not under the jurisdiction of your state, province, and country. Some data protection legislation and regulations may vary depending on your location. By signing up from our website, you consent to the transfer of such information subject to any existing laws.

• DATA DISCLOSURE

We ensure and manifest our commitment to maintain the security of the uploaded information by members, clients, and end-users. We do not rent, sell, or share personal information about you with non-members or non-affiliated companies. We will use all reasonable efforts to ensure that your personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.

A member may connect with another member or view another member's information upon completing a secure logon process only if another member consents to display contact information.

Your Data Protection Rights

For the purposes of complying with the U.S. Federal Trade Commission (FTC), GDPR, and other applicable privacy rules and laws, US Senior Pickleball ensures that you have the right to exercise the following regarding your personal data:

- You have the right to request access to your personal data from us and get copies for your personal use. Service fees may apply when requesting copies.

- You have the right to review your stored personal data and correct any errors for more accurate information.
- If you are uncomfortable with us using your data for marketing, you may opt-out of receiving marketing communications from our website.
- You have the right to report any breach of your privacy rights to relevant authorities.
- You are entitled to request for the deletion of your personal data from our website subject to any applicable rules, regulations, and policies.
- You may suppress other members in good standing from viewing information you provide by changing settings in your profile
- If you do not agree with the use of your personal data, you may request to withdraw your consent.

You are also protected by the U.S, Federal Trade Commission and other relevant federal and state data protection legislation against any deceptive practices and breach of federal privacy and data protection regulations.
